Essential Medicines (WHO)

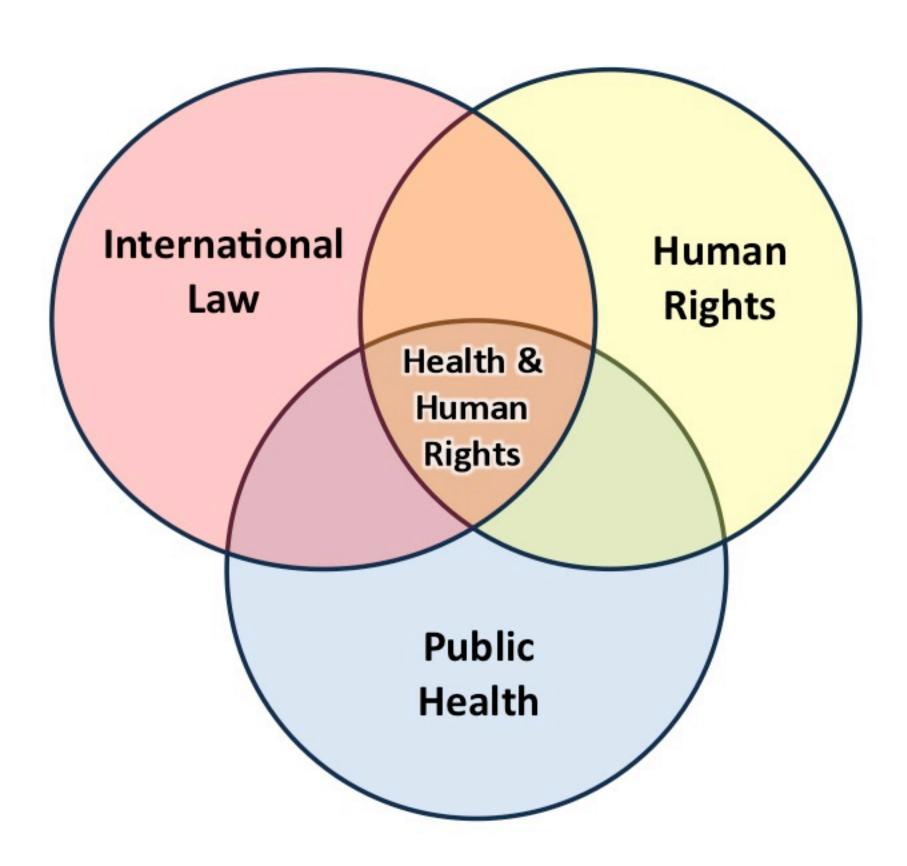
- Satisfy priority health care needs of the population
- Selected with due regard to public health relevance, evidence on efficacy and safety, and comparative cost-effectiveness

Medicine as a private commodity

- Need property rights to drive innovation
- Medicines exist
 because of market
 systems
- Respect for private property
 - Without guarantee of profit, no incentive to invent

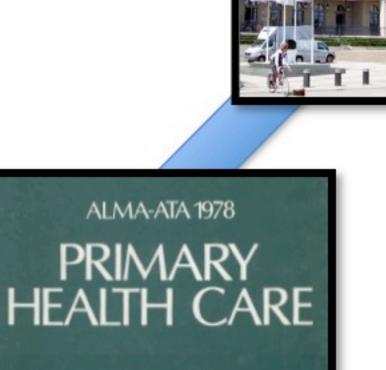

WHO Constitution (1946)

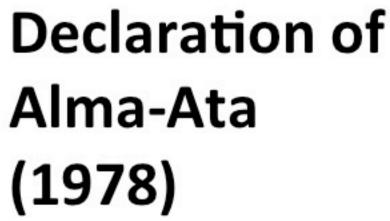

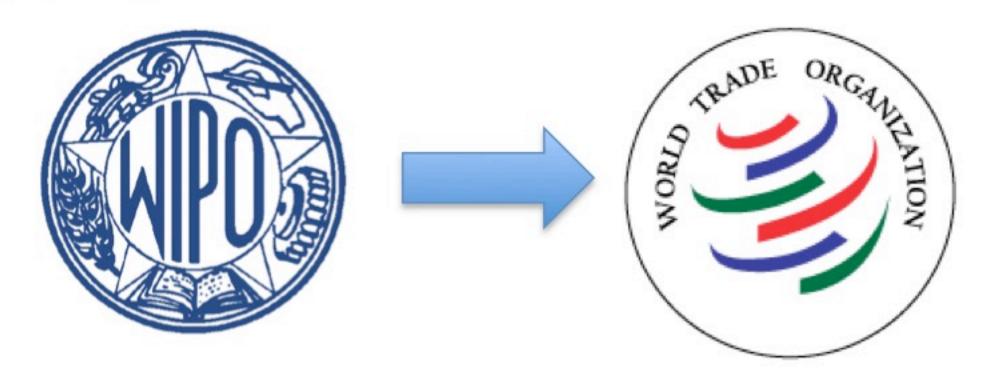


Affordability & the Principle of Progressive Realization

- A state must take steps to operationalize the right to health only "to the maxiumum of its available resources, with a view to achieving progressively the full realization of the rights."

TRIPS

Agreement on trade related intellectual property rights



- Uniform protection of Intellectual Property
- Patents (20 years +)
- Enforcement through WTO Panel





- Establishes minimum standards in the field of intellectual property and enforcement obligations
- All WTO Members must incorporate these standards into their national intellectual property legislation
- Disputes between Members are subject to the WTO dispute settlement mechanism
 - Parallel Importation
 - Compulsory Licensing

Doha Declaration on the TRIPS Agreement and Public Health

"We agree that the TRIPS Agreement does not and should not prevent members from taking measures to protect public health. Accordingly, while reiterating our commitment to the TRIPS Agreement, we affirm that the Agreement can and should be interpreted and implemented in a manner supportive of WTO members' right to protect public health and, in particular, to promote access to medicines for all."

U.S. Role in Doha Negotiations

- Weakened U.S. opposition on the subject
 - Result of the U.S.'s own consideration of compulsory licensing of the drug Cipro in the face of the U.S. anthrax scare (September 2001)
- U.S. has systematically attempted to weaken consensus on the Declaration since the Doha Conference





UN Commission on Human Rights (2005)

 "access to medication in the context of pandemics such as HIV/AIDS, tuberculosis and malaria is one fundamental element of achieving progressively the full realization of the right of everyone to the enjoyment of the highest attainable standard of physical and mental health"

International Cooperation

- UDHR "everyone is entitled to a social and international order in which the rights and freedoms set forth in this Declaration can be fully realized."
- Does patent law conflict with the right to health?
 - Should patent law yield to human rights?
- GC 14 "it is particularly incumbent on State parties and other actors in a position to assist, to provide 'international assistance and cooperation, especially economic and technical' which enable developing countries to fulfill their core and other obligations."
